E Division Traffic Services manages and supports the ALPR program for all RCMP and Independent police forces in BC using IRSU funding to provide one full time program manager and one full time Informatics IT support person. There are currently 29 ALPR units working in BC with 24 in IRSU units, 3 at IMPACT, 1 at VicPD, and 1 at VPD. In addition, 10 ALPR units are waiting for installation in IRSU units and several Detachments are considering purchasing ALPR units.

ALPR is a valuable tool for police, a priority of IRSU and the provincial government, and

BC is a leader in Canada in the development and use of ALPR technology. The growth of the ALPR program in BC, and the introduction of the new PIPS technology, has identified several important issues that need to be resolved before the program can continue to grow. Until these issues are addressed E Division Traffic Services and Informatics will not provide support to any additional ALPR units purchased by RCMP Detachments or Independent police forces and we are delaying the installation of the 10 ALPR units in IRSU vehicles. The 29 ALPR units we currently support will continue to be supported.

Issues to be resolved:

1. Police services requires a strategic plan for IRSU that includes performance measures
2. Additional IRSU funding for current program and cost recovery plan for non IRSU units
3. New PIPS technology requires changes to meet privacy commissioner guidelines, data collection needs and performance measures, and to automate the system to reduce administrative burden and costs
4. Communications strategy to maximize the value of ALPR
5. RCMP policy needs updating
6. Retention of secondary (non hit) data

I anticipate having these issues resolved by Christmas as my resources are committed for the next several months to several high priority major projects; new administrative impaired driving sanctions, TSMIT, and the traffic prolific offender management program.

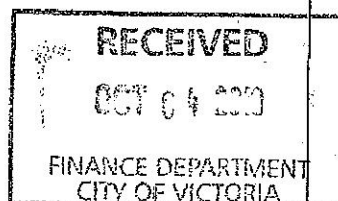

Looks like the Dept. may be considering another ALPR for traffic enforcement.

It would appear from the terms/conditions the ALPR unit remains the property of IRSU and E Div policy must be adhered to. Although we would be operating the unit, the information actually collected, stored etc... would be under the care and control of IRSU. I would think that the privacy issues would filter through the RCMP. Would our policy mirror E Div policy?

This is not urgent... just something we can look at in the New Year.
